MEETING OF FIRE COMMISSIONERS

WEDNESDAY, NOVEMBER 2, 2016

MINUTES

CALL TO ORDER: The monthly meeting of Fire Commissioners was called to order at 7:00 p.m. and a moment of silence was observed.

PRESENT: Present at the meeting was, Chairman Tanya Farmer, Commissioner Jerry Hughes, Commissioner Ariel Marzouca-Jaunai, Chief Robert Farmer Treasurer Errol Bartley, Fire Marshall Bill Lewis, Firefighter Vincent Jaunai, Barbara Bagnall, Keith Bennett, Jacqueline Massey Greene, Anne Wall, Karen Jackson, Barbara Wilson, Rebecca Hayes, Firefighter Dwayne McLish, Firefighter Robert Farmer III and District Clerk Valda Thompson.

READING OF PREVIOUS MINUTES: District Clerk Valda Thompson read the minutes from last month's meeting. A motion was made to accept the minutes as read. The motion was seconded. The motion carried.

CHIEF'S REPORT: Chief Farmer stated that there were 39 calls in the month of October. There were 26.8 manpower hours. Chief Farmer stated that there was a car accident in which the vehicle damaged the Condo structure. Three vehicles at 9 Camelot Drive were on fire and with very little manpower the Department contained the fire. There was an incident at 31 Tobey Road where Chief Farmer and Deputy Fire Marshall Nelson assisted the PD with shutting down a party because the building was not zoned to host it. The AFG Grant period opened between October 11 -14. Chief Farmer stated that he has 75% of the grant application to request funds to replace SCBA already written. November 11, 2016 is the deadline for the grant application to be submitted.

HOUSE CAPTAIN'S REPORT: Chief Farmer reported on behalf of Captain Nelson that the flood lights in front of headquarters have been replaced with energy efficient bulbs.

SAFETY OFFICER'S REPORT: Chief Farmer reported on behalf of Safety Officer Serignese that the Safety Committee will be meeting soon.

COMMUNITY OUTREACH REPORT: Firefighter Jaunai stated that October was fire safety month. On 11/12/16 the District was invited to Hope Seventh Day Church for Firefighter's Appreciation Day at 11:00 a.m. Vincent Jaunai will attend, everyone is welcome to join.

DEPARTMENT CONCERNS/GOODS AND WELFARE: Commissioner Ariel Marzouca-Jaunai made a motion to participate in the Thanksgiving basket program and the Adopt a Family program for Christmas with the town Leisure Youth Services. Total donation in the amount of \$1500.00. The motion was seconded. The motion carried.

Treasurer Bartley requested that the District order a date stamp in order to label when Assistant Chief Rickis receives bills in the mail. Commissioner Farmer asked Clerk Thompson to have the stamp ordered.

CITIZEN'S STATEMENT AND COMMENTS: Jacqueline Massey-Greene requested that the Commissioners come together in peace and asked that the Board begin working on Bylaws. Ann Wall also asked about the Bylaws. Chairman Farmer stated the Board had been advised by the Attorney not to discuss things not on the agenda.
